2. COMPOSITION / INFORMATION ON INGREDIENTS

Contains: Between 5-10% cationic surfactant.

3. HAZARDS IDENTIFICATION

Main hazards: No significant hazard.

4. FIRST AID MEASURES (SYMPTOMS)
